## **Executive Officers' Report**

#### 2013/14 - A Year of an Enhanced Profile for Care Leavers

With another year drawing to a close, it is a good opportunity to reflect on the achievements that CLAN has accomplished on behalf of our members.

Since the last AGM in Adelaide in 2013 CLAN has been kept very busy working to assist Care Leavers from all parts of Australia to come forward to the Royal Commission and tell the highest office in Australia of their abuse and trauma history in Australia's orphanages, children's Homes and foster care and other institutions eg. mental hospitals, goals. The oldest person we have supported at the Royal Commission is 91 years old.

We had 30,000 special Royal Commission flyers made "Some Memories Never Fade". We thank our members for giving them out in their local Community.

We continue to liaise with Federal and State Ministers and their advisors in each state of Australia. CLAN would like to acknowledge the ongoing support and funding we receive from the DSS and Victoria, NSW, ACT and SA governments for their funding to CLAN. I would especially thank the Federal Minister for the funding for 14<sup>th</sup> Anniversary and RC forum. We have had meetings with Kevin Andrews the Federal Minister's Chief of Staff in Canberra. Kevin Andrew's advisor attended the Bankstown Office to discuss Care Leaver issues.

CLAN continues to create awareness of the long term legacy of Care Leaver's lives, including ALL forms of abuse, not just sexual use but also the legacy of losing our families.

We continue to work effectively with the Royal Commission, Government Depts and other agencies that have responsibility for our issues. During the year we were invited to speak to New South Wales Department of Community Services Royal Commission Team about CLAN's history.

In July this year we hosted our 14th Anniversary & Royal Commission Forum: "Road to Recovery - Truth, Justice and Redress for ALL Australian Care Leavers." We were very fortunate that the Chair of the Royal Commission Peter McClellan AM QC was our keynote speaker. It was a very successful two days and we had Clannies from every state of Australia attend.

The Interim Report of the Royal Commission was released at the end of June. In Volume 2 on page 10 it includes the voices of Care Leavers with names changed.

Final report of the Victorian Inquiry into the Handling of Child Abuse by Religious and other non-government organisations - 'Betrayal of Trust' was released November 2013. Sadly State government run orphanages and Homes were excluded from this important inquiry.

Both reports make an interesting read!

On the 30th August 2013 I attended the DART Centre Forum at the ABC Studios alongside the Chair of the Royal Commission, Justice Peter McClellan. This was a workshop for Journalists covering the Royal Commission.

I also visited South Australian Prison of Port Lincoln, NSW Prisons in Junee and Long Bay Jail. I met up with care leavers who had never heard of CLAN and it was a great opportunity to provide information about our services and the Royal Commission to the men.

On the 6th November 2013 CLAN Conducted a meeting with the Police Service Sex Crimes, Shelly Johns and Michael Haddow. Knowmore Legal Services also attended this forum with many Clannies attending and having the opportunity to ask many questions.

I was also interviewed by the ABC TV News as well as Grahame Richardson's show named "Richo" on Sky, promoting CLAN's needs.

I would like to sincerely thank the dedicated and committed team at CLAN, I would not be able to do my job as the CEO of CLAN without them.

Julie, Natalie Janis, Kylie, Vicki, Kristen and lastly Helene provide lots of support, care, commitment and laughter in the White House headquarters of CLAN in Bankstown. We are very, very lucky to have them working for CLAN, they truly care about the members.

## Presidents' Report

Helene has a strong background working in an administrative and project management capacity in the telecommunications, government and not for profit sectors and has been with CLAN for five months.

## **Royal Commission Report**

Much of CLAN's energies have been directed toward ensuring our members are seen and heard throughout the Royal Commission process.

CLAN team members visited the Royal Commission Offices in August 2013 and were shown through the two hearing rooms and the private meeting rooms at Governor Macquarie Tower, 1 Farrer Place Sydney.

This visit was a good introduction, ahead of the first scheduled public hearing day (on Monday 16 September) where CLAN had a presence outside the building entrance on opening day.

30,000 CLAN Royal Commission flyers were printed and widely distributed during September, ensuring members and care leavers know of the support on offer from CLAN as they engage with the Royal Commission process.

We attended a Royal Commission Referral Protocols Working Group meeting in October that aimed to improve linkages and referrals between the Royal Commission and the various organisations funded to provide support services.

CLAN attended Royal Commission public hearings held in Perth in October 2013 and later that month attended a meeting with Victorian Police Taskforce SANO in Melbourne.

We also convened a meeting was in November at the Bankstown office for CLAN members to discuss police/ legal matters associated with the Royal Commission, with NSW Police and the Knowmore legal service attending the meeting.

The Royal Commission's public hearing into the North Coast Children's Home Lismore, was an historic occasion – the first time a Home had been placed in the national spotlight – and CLAN held a awareness raising event outside the Royal Commission in Sydney This generated

Commission in Sydney. This generated lots of media attention.

A meeting was held between CLAN and Justice Peter McClellan on 27th November 2013 to discuss matters of concern and to seek his agreement to participate in the proposed CLAN 14th anniversary conference in July 2014.

December was a very busy month, with the Royal Commission Public Hearing into the Catholic Churches 'Towards Healing' protocol. January 2014 continued the pace, especially once the Royal Commission Public Hearing into

the Salvation Army Boys Homes in Qld and NSW got underway.

The Royal Commission Public Hearings were on again on key topics of interest to CLAN members, and resulted in many days of silent protests and support of members attending these hearings.

I (finally) got to provide a successful training halfday to the Royal Commission staff. Another day will be held in March for other staff.

Travelling continued to feature in 2014, with CLAN travelling to Western Australia for the Public Hearings of the Royal Commission and to support our members at the Royal Commission private hearings in every state of Australia.

In June, we issued a media release strongly expressing our frustration towards the Federal Government's decision to divert \$6.7 million from the budget of the Royal Commission on Institutional Responses to Child Sexual Abuse.

# Information & Support Services

## Counselling Services


CLAN receive several phone calls and emails every day from people seeking our assistance and information. A total of 383 information packages were sent out to people wanting to know about CLAN over the last year.

We also receive requests from Care Leavers to help them access their personal files, information about legal issues, history of orphanages, compensation and redress, referral to other support services, enquiries about CLAN's library and information about the Royal Commission. 65 Members were supported in attending private Royal Commission hearings throughout the year.

CLAN has written several letters of support for people who sought our assistance with disability pension, application for priority housing, medical and dental services and general support. We have also supported members who visited court to face their abusers.

CLAN has also successfully applied for records on behalf of Care Leavers who are currently in gaol. CLAN has visited a number of prisons and has applied for and delivered personal files/records to people who are currently in gaol, as well as providing training to prison staff about the particular needs of and issues faced by Care Leavers.

The CLAN library has over 1000 books about the various orphanages, Children's Homes and other institutions across Australia and overseas as well as self-help books and autobiographies of Care Leavers which have continued to be borrowed throughout the last year.

It has been another busy year for the CLAN counsellors helping care leavers with submissions to the Royal Commission, supporting care leavers at private meetings at the Royal Commission.

CLAN has been inundated with requests for counselling sessions and there has been a significant increase in the number of Care Leavers and their family members using our free counselling service. Due to the increased interest in counselling and accessing state ward records CLAN has now employed a caseworker full time.

The CLAN counselling service is open to CLAN members, their families, as well as Care Leavers who are not members of CLAN. Counselling is conducted both face to face in our offices in Bankstown and Melbourne, as well as over the phone, allowing many Care Leavers who cannot physically access a counsellor the chance to use a counselling service in the privacy of their own home.

The CLAN counselling service not only offers traditional free counselling sessions to Care Leavers members, non-members and their families. We support Care Leavers with organisations such as Centrelink, Department of Housing, as well as writing support letters, assistance with the Victims Compensation Scheme, help with paperwork for various government agencies, support with court cases, writing submissions on behalf of Care Leavers to the Royal Commission, reporting abuse to the Police and support for their private session with the Royal Commission. Our caseworker helps care leavers with applying for records, doing family research etc.

Please remember that there are times everyone needs support or just someone to listen to what they are saying. If you feel that this may be you then please contact CLAN and we will do what we can to assist you.

## Caring for Forgotten Australians DVD

Aged care has been raised as an area of particular anxiety for Care-Leavers given their previous experiences in institutional care. The Australian Government has classed Care-Leavers as a special needs group within the Aged Care Act.

In 2003, with the support of the Department of Health and Ageing (DoHA), Aged Care Channel (ACC) was established to enable staff and residents of residential care homes access to accredited education and training programs and support the care of Australia's ageing population.


The "Caring for Forgotten Australians" DVD was published on Mar 11, 2014 by ACC Residential Care CORE Program. The DVD discusses the unique issues facing older people who were

raised in institutions or foster homes, many whom have a dislike and distrust of institutions including care homes and identify strategies to address their specific needs.

This DVD is designed to give carers a better understanding of how care leavers feel, and why they may present with challenging behaviour. It also provides them with strategies to ensure that their last years in care are better than their first years in care.
