# **Executive Officer's Report**

It has been an extremely hectic 12 months since our AGM in Melbourne. In November last year, the Turnbull Government announced its proposed 'Opt-in' National Redress Scheme. This scheme gives state governments, churches and charities the option of joining the national scheme or choosing not to join. While we welcomed the announcement and progress being made on national redress, CLAN was deeply disappointed the Federal Government chose to ignore the number one recommendation of the Royal Commission into Institutional Responses to Child Sexual Abuse: the need for a fully National Redress Scheme involving <u>all</u> responsible institutions.

Much of our campaigning since the Federal Government's announcement has focused on maintaining the pressure on state governments, churches and charities to join the national scheme. So far only the Catholic Church has committed fully to a National Redress Scheme and backed up its promise with funding.

As CLAN CEO, I was invited to join the Independent Advisory Council on Redress. This 15-member group met around half a dozen times in the first half of the year to inform the process of establishing the Federal Government's scheme and it was a great privilege to represent Care Leavers and advocate on their behalf during those meetings.

In May, I was joined by CLAN co-founder Joanna Penglase, President Vlad Selakovic, Vice President Frank Golding, Past President Jim Luthy and Associate Professor Jacqui Wilson at the *Setting the Record Straight for the Rights of the Child National Summit* in Melbourne's Federation Square. Joanna, Frank, Jacqui and I presented papers at this important conference that explored ways to improve the archiving and access to records for Care Leavers.

CLAN has held many protests throughout the year. In addition to National Redress and better access to records from state governments and other institutions, our protests have focused on our campaign for a National Police Apology, and representing Care Leaver issues during public sessions of the Royal Commission.

As the Royal Commission reaches its final months, CLAN continues to support many Care Leavers who have been telling their stories in private sessions with the Commissioners.

The Royal Commission is due to present its final report to the Governor-General Sir Peter Cosgrove on December 15, 2017. This will conclude a four-and-a-half-year investigation that has been historic in both its scale and national impact.

The Royal Commission gave Care Leavers a chance to have their voices heard by the highest office in the land. Their stories are now part of Australian history and can never be covered up or ignored again.

During the process, CLAN learnt to trust the Royal Commission and the Commissioners and they worked hard to gain our trust. They listened and respected our point of view. Royal Commission Chair, Justice Peter McClellan, ensured the doors were never closed during a public hearing. This was the result of CLAN's advocacy on behalf of Care Leavers who fear confined spaces after being locked in cupboards, cells and cellars as children. Justice McClellan has admitted he wasn't aware of the long term and lasting impact of child sexual abuse.

Not many judges have been brave enough to admit that and we thank him for highlighting the need for continued advocacy for survivors.

I would like to thank Justice McClellan and Commissioners Jennifer Coate, Bob Atkinson, Helen Milroy, Andrew Murray and Robert Fitzgerald and all the Royal Commission staff who have worked so closely with us. Your work has lifted the burden of silence from the shoulders of many Care Leavers and we are hugely grateful for your determination to right the wrongs of the past.

I must also thank the dedicated team in the office at CLAN for their wonderful work supporting the CLAN committee and myself. Thank you Julie, Natalie, Janis, Kristen, Steven, Shanice, Kylie, Pauline and our wonderful cleaner, Yvonne. I also want to acknowledge our tireless volunteers Stewart and Michael. Stewart spends every Monday cataloguing items in the Australian Orphanage Museum and Michael keeps the CLAN lawns looking their best, travelling two hours each way from Moss Vale to our office. Thank you all for your cheerfulness during the busy times and your care and attention to the needs of Care Leavers.

I sincerely thank CLAN Committee members, Vlad Selakovic, Frank Golding, Stewart Quinn, Pat Griffiths, Rhonda Jantezki, Pat McNair in New Zealand, Jenny Brownley and Carolyn Frawley for making time for our committee meetings every month and working so hard to help CLAN run smoothly.

And lastly, I want to thank all the Clannies who come along to our protests, often travelling long distances at your own expense. Your commitment on behalf of all Clannies is immeasurable. Thankyou too to the Clannies who have written to the Prime Minister and Federal and State Members of Parliament as we continue to campaign for justice for Care Leavers.

It is an enormous privilege to represent Care Leavers and advocate for better outcomes from churches, charities and state governments. We have made great strides in recent years, but we will never, ever go away until we reach our goal of Care Leaver recognition, justice and National Redress, for all forms of Abuse, Neglect and Child Labour.

#### Kristen Harris


#### Caseworker/Case Management/Counsellor





# Media Report

#### CLAN in the Media

Over the past twelve months, CLAN has distributed 15 media releases and featured in more than 200 news reports across newspapers, radio, television and news websites. This extensive media coverage has helped CLAN cement itself as a respected voice in the national conversation, particularly with regards to coverage of the Royal Commission. Of particular note, were the many interviews on national media featuring CLAN CEO Leonie Sheedy, CLAN committee members and other Clannies sharing their personal stories. Photos of Clannies holding protest signs regularly feature in news reports about the Royal Commission. The media coverage supports CLAN's campaign for National Redress, for a national Police apology, for improved access to records and for funding for Australia's Orphanage Museum. Media coverage also ensures that Clannies voices are heard, our stories are remembered and the history we have lived is never forgotten.

This passage from an article in the 'Saturday Paper' reporting Cardinal George Pell's Melbourne court appearance in July shows the CLAN colours of blue and yellow are highly recognised and identifiable as a sign of protest and survival:

"Most had arrived early. Many before sunrise. Church abuse victims, Catholic supporters. You could see the colours of survivor groups – the blue of heaven, the yellow of light and spiritual renewal – on scarves and beanies."

# **Counselling Report**


It has been another busy year for the CLAN counsellors helping Care Leavers with submissions to the Royal Commission, and supporting Care Leavers at private hearings at the Royal Commission. CLAN has been inundated with requests for counselling sessions and there has been a significant increase in the number of Care Leavers and their family members using our free counselling service.

The CLAN counselling service is open to CLAN members, their families, as well as Care Leavers who are not members of CLAN. Counselling is conducted both face to face in our offices in Bankstown and Melbourne, as well as over the phone, allowing many Care Leavers who cannot physically access a counsellor the chance to use a counselling service in the privacy of their own home.

The CLAN counselling service not only offers Free counselling sessions to Care Leavers and their families. We also support Care Leavers with:

- Organisations such as Centrelink/Department of Housing,
- Writing support letters,
- Assistance with victim's compensation scheme,
- Help with paper work for various government agencies,
- Support with court cases,
- Writing submissions on behalf of Care Leavers to the Royal Commission and attending private hearings with the individual.
- Reporting abuse to the police.



# **Casework Report**

CLAN assists Care Leavers in family history research and accessing their personal files and Orphanage Records. CLAN assisted 193 people this year in obtaining Family War Records, State Ward Records & Past Providers Records.

The graph below shows that in the last financial year CLAN has applied to every State and Territory for Care Leaver records.





1,040 calls were made to State Governments., Births Deaths & Marriages, Health Services/Hospitals and various organisations, liaising with other professionals in order to assist in obtaining any information on records.

CLAN also assists Care Leavers obtain War Service Records of relatives of the Care Leaver. Last year, CLAN obtained 20 different War Service Records for Care Leavers and their family.

# **Information Report**

CLAN receives several phone calls and emails every day from people seeking our assistance and information. A total of 246 information packages were sent out to people wanting to know about CLAN and our services we provide, and a total of 11,000 phone calls were taken.





# **Royal Commission Report**

The Royal Commissioners and the team have worked tirelessly to give respect, care and commitment to Care Leavers who bravely came forward to tell what happened to them as children.

Respect is a very important word, Care Leavers have never been respected in our childhoods or in our adulthoods, we were left to fend for ourselves alone in the world.

However, the Royal Commission team listened respectfully to Care Leavers voices and gave us the respect which was so callously denied by the very people entrusted to care for us.

Since the Royal Commission was established in 2013 CLAN has supported 139 Care Leavers across Australia to attend their private session.

CLAN has written the following submissions to Royal Commission:

- Best Practice Principles in Responding to Complaints of Child Sexual Abuse
- Civil Litigation
- Criminal Justice Submission
- Records and Recordkeeping Practices
- Redress and Civil Litigation
- Response to Issues Paper 10: Advocacy and Support and Therapeutic Treatment Services

CLAN has attended all public hearings that involved Orphanages, Children's Homes or Foster Care, the only one we didn't attend was the Retta Dixon Home public hearing in Darwin.

However, we followed it via the Royal Commission website.

Sincere thanks to the team in our national office at Bankstown for all their commitment they give to the Clannies and the support they give to me. It has been a hectic 4 years during the Royal Commission. They have given true commitment to the Clannies and the staff are highly valued by Care Leavers.

A special mention goes to CLAN senior counsellor Natalie Wallace for tremendous work with all of the submissions, we couldn't have done it without her input, knowledge and writing skills.

In the past 12 months, Clannies have kept up a presence outside the Royal Commission with our posters and creating awareness of the terrible crimes committed on vulnerable children in Australia's Orphanages, Children's Homes and Foster Care.

Full credit to those Care Leavers who got up early, travelled long distances and paid out of their own pockets to attend the Royal Commission rallies and our monthly protests for justice and Redress for all Care Leavers.

Australia and Australians should be so proud of your efforts to bring a light to Australia's hidden horrid child welfare history.

We are anxiously awaiting the next 4 weeks for the final report of the Royal Commission, which will be delivered to the Governor General on 15th December 2017. We understand it will be 21 Volumes long.

The final report will be an important national significant document that all Politicians, State and Federal Governments, Churches, and Charities must take seriously and work in a bi partisan manner to make sure that justice is done for Care Leavers.






# **Financial Report**

Materiality

No other applicable Accounting Standards, Australian Accounting Interpretations or other authoritative pronouncements of the Australian Accounting Standards Board have been applied.

The financial report has been prepared on an accruals basis and is based on historic costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following material accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report:

#### **Inventories**

Inventories are measured at the lower of cost and net realisable value. Cost of inventory is determined using the first-in-first-out basis and are net of any rebates and discounts received.

#### Plant and Equipment

Plant and equipment is carried at cost or fair value less, where applicable, any accumulated depreciation and impairment of losses. Plant and equipment is depreciated on a straight-line basis over the assets useful life to the Association, commencing when the asset is ready for use.

#### Depreciation

The depreciable amount of all plant and equipment is depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use.

#### NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 JUNE 2017

#### **Employee Benefits**

Provision is made for the association's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits that are expected to be wholly settled within one year have been measured at the amounts expected to be paid when the liability is settled.

Employee benefits expected to be settled more than one year after the end of the reporting period have been measured at the present value of the estimated future cash outflows to be made for those benefits. In determining the liability, consideration is given to employee wage increases and the probability that the employee may satisfy vesting requirements. Cashflows are discounted using market yields on high quality corporate bond rates incorporating bonds rated AAA or AA by credit agencies, with terms to maturity that match the expected timing of cash flows. Changes in the measurement of the liability are recognised in profit or loss.

Employee benefits are presented as current liabilities in the balance sheet if the association does not have an unconditional right to defer settlement of the liability for at least one year after the reporting date regardless of the classification of the liability for measurement purposes under AASB 119.

#### **Taxes**

#### **Income Tax**

No Income Tax is payable by Care Leavers Australasia Network Incorporated as Section 50-5 of the Income Tax Assessment Act 1997 exempts Charitable Institutions from Income Tax

#### Goods & Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of goods and services tax, except:

- (i) where the amount of GST incurred is not recoverable from the Australian Tax Office. It is recognised as part of the cost of acquisition of an asset or as part of an item of the expense.
- (ii) receivables and payables are shown inclusive of GST.

#### Cash and Cash Equivalents

Cash and short-term deposits in the balance sheet comprise cash at bank and in hand and short-term deposits with an original maturity of three months or less plus bank overdrafts. Bank overdrafts are shown on the balance sheet as current liabilities under borrowings.
